## Hard Facts

An increasing number of students are struggling to cope, let alone thrive, in the physical school setting. The main causes of their anxiety, panic and overwhelm are incredibly difficult for traditional schools to be able to solve sustainably.

Evidence shows that schools & academies attempt to address such student issues but are unfortunately limited due to the complex nature of student triggers & trauma, a lack of resources & training. Despite best efforts, often these situations ultimately result in poor parent satisfaction & disillusion towards the institution.

## The reality of student experience

Student mental health challenges and anxiety have increased significantly since the COVID-19 pandemic & resulting lockdowns.

CAHMs have long waiting lists and offer minimal support for young people & their families whilst they are waiting to be seen.

The Department for Education requires schools to enforce strict, broad-brush attendance policies which fail to contextualise student absence, not taking into consideration the impact of emotional & mental health struggles on a child's attendance record.

Schools struggling to expand provision to meet SEND adjustments due to underfunding, a lack of resources & limited training.
